Fire Permits

By-Law No. 1295-10 states that fire permits are required for burning during the fire season (April 1st – October 31st) within Municipal Boundaries. The conditions of the By-Law shall be complied with and Fire Permits shall be purchased. There is to be no day burning during the fire season. In accordance with

the User Fees and Charges By-Law the fees for fire permits are as follows:

Annual Permit:	\$40.00
4 Day Permit:	\$10.00
Incinerator Permit:	\$50.00
Level 3 Permit:	\$350.00
Inspection Fee	\$35.00
